Limited Warranty for Textile Products

- **1. Warranty Coverage:** This warranty is given by AB Ludvig Svensson ('Svensson') to the original purchaser ('Customer') of textile products ('Product(s)) under the following conditions:
- **2. Warranty period:** Svensson warrants the Product(s) to be free from defects in materials and workmanship for a period of ten (10) years from the date of delivery (the 'Warranty Period').
- 3. Scope of warranty: This warranty covers:
- Defects in materials and workmanship.
- Durability and functionality of the Product(s) under normal conditions of use.
 - **4. Warranty conditions:** The warranty is subject to the following conditions:
- The product(s) must be used in an environment appropriate to its design and intended use.
- Proper care and maintenance in accordance with the product specifications must be followed.
- Upholstery fabrics must be used on appropriate furniture and be properly upholstered.
- Normal use is defined as use for eight (8) hours per day with regular maintenance.
 - 5. Exclusions: this warranty does not cover:
- Wear and tear caused by abnormal or improper use.
- Damage due to misuse, negligence, accidents or mishandling.
- Costs associated with re-upholstery, transportation or other ancillary costs.
- Changes or additions made by the customer to the product(s).
- Effects of external forces, pollution or other environmental factors beyond Svensson's control.
 - **6. Remedial measures:** If a defect occurs and a valid complaint is received within the Warranty Period, Svensson will, at its own discretion
- Replace the defective Product(s) or parts thereof free of charge if the complaint is received within one year from the invoice date.
- If the claim is received after one year from the invoice date, Svensson will replace the Product(s) in question in whole or in part, subject to a reduction in value of 10% of the Product's price in the current price list multiplied by the number of years the Product has been used from the invoice date. For example, if the claim is submitted 3 years after the invoice date, the customer will be charged 30% of the current price of the Product.

- 7. Claim procedure: To make a warranty claim, the Customer must
- Contact Svensson with information about the fault.
- Present the purchase invoice and all relevant documentation.
- Follow any additional instructions provided by Svensson for the claim process.
 - **8. Limitation of liability:** Svensson's liability under this warranty is limited to the replacement of the defective Product(s). Svensson is not liable for indirect, consequential or incidental damages arising from the use of the Product(s).
 - **9. Governing Law:** This warranty shall be governed by and construed in accordance with Swedish law. Disputes arising out of this warranty shall be submitted to mediation and/or arbitration in accordance with the Mediation and Arbitration Rules of the West Sweden Chamber of Commerce Board of Trustees.'

10. Additional conditions:

- The warranty is non-transferable and applies only to the original purchaser.
- All implied warranties, including implied warranties of merchantability and fitness for a particular purpose, are limited to the duration of this express warranty.
